hereby apply for an order under section 53(2) of the Wildlife and Countryside Act 1981 modifying the definitive map and statement for the county of Hampshire and for the borough of Wokingham by adding to the map and statement:

- a byway open to all traffic along Jouldings Lane in the borough of Wokingham from the turning to Jouldings Farm at A (SU75296351), southwestwards to the north side of Jouldings Ford (SU75256348), and
- a restricted byway from the said north side of Jouldings Ford southwestwards to the county boundary in Jouldings Ford (SU75246347), and south-southwestwards to Well House Lane at D (SU75126322 in Hampshire).

with a width of between 7.5 metres and 37 metres as specified in the attached document summary at item 3, and shown on the map set out in the summary at item 1.
